## Maher Bros • History

- FOUNDED IN 1922 BY D.H. MAHER AND M. MAHER
- FIRST I OCATED AT 129 F. COLLEGE STREET IOWA CITY
- 1928 MOVED TO 106 S. DUBUQUE STREET. DENNY MAHER ACQUIRED FULL OWNERSHIP OF COMPANY
- 1935 ROBERT BOTHELL JOINS MAHER BROS, AS BOOKKEEPER
- MAHER BROS, OPENS TERMINAL IN CHICAGO
- WAREHOUSE IS OPENED AT 306 S. GILBERT STREET
- 1941 WWII
- 1953 BECOMES AN AGENT FOR MAYFLOWER TRANSIT CO.
- 1954 BUSINESS IS PURCHASED BY BOB BOTHELL AND EARL RILEY
- 1968 EARL RILEY ACQUIRES 100% OWNERSHIP OF COMPANY
- 1969 EARL AND IRENE RILEY BUILD NEW WAREHOUSE AT 2470 S.
  RIVERSIDE DRIVE
- 1977 EARL RILEY SERVES AS PRESIDENT OF MAYFLOWER WARFHOUSE ASSOCIATION
- 1983 TOM RILEY JOINS COMPANY
- 1985 TIM RILEY JOINS COMPANY
- 1988 EXPANDS INTO CEDAR RAPIDS MARKET WITH PURCHASE OF CEDAR RAPIDS TRANSFER

## Maher Bros • History

- 1992 TOM AND TIM RILEY PURCHASE COMPANY FROM THEIR PARENTS
- 1995 BECOMES AN AGENT FOR ALLIED VAN LINES.
- 1998 BUILDS CURRENT WAREHOUSE AT 370 50TH AVE. DR. S.W. CEDAR RAPIDS
- 1999 BUILDS CURRENT WAREHOUSE IN DAVENPORT IOWA
- 2010 PURCHASES BELTMANN MOVING AND ENTERS THE DES MOINES MARKET
- 2016 PURCHASES THE ASSETS OF ACE MOVING DES MOINES
- 2019 PURCHASES THE ASSETS AND BUILDING OF SMOLDT MOVING DES MOINES
- 2022 ADDS A 15,000 SQUARE FOOT ADDITION TO DES MOINES BUILDING
- 2022 CELEBRATES 100 YEARS IN BUSINESS
